ICD-10

The International Classification of Diseases (ICD) is founded, maintained, and published by the World Health Organization (WHO), located in Europe. ICD-10 plays a key role in being able to code and classify mortality data from death certificates. It far exceeds its predecessors in the number of codes provided, leading to far more accurate diagnosis and reporting. Reimbursement and quality needs can also be much better met under the new system.

ICD-10 provides enormous opportunities for improving documentation processes for health records with:

- A better coding classification system
- Refinement to financial/reimbursement models
- Improvements in clinical specificity resulting in improvements to patient safety functions

The Health Insurance Portability and Accountability Act (HIPAA) is an extensive piece of legislation that requires the standardization of electronic patient health, administrative, and financial data. HIPAA-compliance necessitates the support of a standard set of codes and guidelines defined by the US government.
