What do patient records mostly look like?

A patient's medical record is ideally, an accumulation of medical information bundled in a single folder with the patient's identification data on the cover. In real life, this information is scattered between several archives (computerized and paper-based) in various locations, often under different identification numbers. Much of the information in the records is obsolete, redundant, duplicated, or indecipherable to the extent that it does not benefit the patient at the point of care.

The debate about patient privacy of medical records

- 1. Ownership of the data. Many hospitals consider the records in their systems to be their property, whereas many patients argue that their medical information is their own.
- 2. Consequently, a distinction has to be made between ownership of the physical record and the right to access (or duplicate) data that are stored in it. Policies on this issue differ substantially between delivery networks, states, and countries.

That said, it is typically agreed that patients have the right to be informed of the general content of their medical record and that patients' care providers must be allowed access to any information that is relevant to a patient's treatment. This approach endorses locking sensitive information (such as psychiatric evaluation or various serological findings) from some care providers but promoting access to what is "needed to know" for the provision of appropriate care. It is thus reasonable to assume that, between the patient and his or her primary healthcare coordinator (such as the family doctor), most of the "critical information" is within reach.

Secure patient information

Healthsoft OMR is a web-based storehouse for patient records that retains patient confidentiality by allowing them to choose the information that they would like to make available.

It is a patient-controlled, "granularly secured," cross-sectional medical record system that is accessible via the World Wide Web. Unlike existing information systems, the patient initiates the service here. The patient's primary healthcare coordinator suggests which clinical content is worth "risking" for the benefit of making it available when needed. The patient secures his or her identity and each data element in the medical record, by specifying the data anyone requesting the information must supply in order to gain access.

From there on, the caregiver can

- Securely store, index, search, retrieve, fax, email, digitally sign or print any type of electronic record
- Access the records from anywhere, anytime

 Once a transcription is printed the status is changed to 'PRINTED' and is no longer available in this view.
- View all printed transcriptions. Transcription in this view should have all general access options.
